BOARD OF ALDERMEN
Meeting

A Special Meeting of the City of Weatherby Lake Board of Alderman was called to order by Mayor Patrick Botbyl, on Wednesday, August 27, 2014 at City Hall, 7200 NW Eastside Drive, Weatherby Lake, Platte County, Missouri at 6:53 p.m..

Aldermen present were: Clark, Stevenson and Finn.

Alderman absent was: Richmond

Also present was: John Reddoch, City Attorney and six (6) member of the public.

Stevenson moved and second by Clark to pass on the first and place on the second **Bill NO. 1193 as Ordinance NO. 1192** an ordinance setting the tax levy of the City of Weatherby Lake, Missouri for the 2014 at the rate of Eight-eight hundredth cents (\$.8488) per hundred dollars (\$100.00) valuation for general operating fund, seventy-seven and twenty-four hundredth cents (.7724) per one hundred dollars (\$100.00) valuation for general obligation bonds fund and eighteen and eleven hundredths cents (.1811) per one hundred dollar (\$100.00) valuation for park board fund, and further providing that said taxes shall be due and payable as of November 1, 2014 and shall be delinquent as of January 1, 2015. Thereafter, a penalty of two per cent (2%) per month shall be added to said tax.

Stevenson moved and second by Finn to approve **Bill NO. 1193 as Ordinance NO. 1192** an ordinance setting the tax levy of the City of Weatherby Lake, Missouri for the 2011 at the rate of Eighty-four and eighty-eight hundredths cents (\$.8488) per hundred dollars (\$100.00) valuation for general operating fund, seventy-seven and twenty-four hundredth cents (.7724) per one hundred dollars (\$100.00) valuation for general obligation bonds fund and eighteen and eleven four hundredths cents (.1811) per one hundred dollar (\$100.00) valuation for park board fund, and further providing that said taxes shall be due and payable as of November 1, 2014 and shall be delinquent as of January 1, 2015. Thereafter, a penalty of two per cent (2%) per month shall be added to said tax. Yeas: Clark, Stevenson and Finn. Absent: Richmond. Motion carried.
